### Overview

- Antitrust – He has tried extended anti-trust cases involving the movie, milk and cranberry industries and claims in defense contracts of anti-trust violations.

- Reinsurance – He has done litigation in the reinsurance field and is familiar with reinsurance treaties. He litigated a major reinsurance matter in London.
